



Admissions Policy

1 Introduction

- 1.1** The governing body of Wickford Primary School applies the regulations on admissions fairly and equally to all those who wish to attend this school. The School Standards and Framework Act 1998 introduced a new framework for school admissions as of September 2000. This policy conforms to the regulations that are set out in that Act and also further explained in the statutory School Admissions Code of Practice and the statutory Appeals Code of Practice.

2 Aims and objectives

- 2.1** We are an inclusive school that welcomes children from all backgrounds and abilities.
- 2.2** All applications will be treated on merit and in a sensitive manner.
- 2.3** The only restriction we place on entry is that of number. If the number of children applying for entry exceeds the places available, we enforce the procedure set out below in order to determine whether a child is accepted or not. It is our wish to allow parent/carers the right to have a place at the school of their choice. However, this is not always possible, due to the excess demand on the school places available.
- 2.4** The level of ability of a child or any special needs that s/he may have plays no part in the admissions policy of this school.

3 How parent/carers can apply for their child to be admitted to our school

- 3.1** As our school is a community school, the school determines the admission arrangements in agreement with the Local Authority (LA). The LA is therefore the 'Admissions Authority' for our school. The regulations for entry to each school, where the Admissions Authority is the LA, are published each year by the LA. Parent/carers can receive a copy of these regulations directly from the LA.
- 3.2** The LA publishes a composite admissions prospectus each year, which gives information about how parent/carers can apply for a place in the school of their choice. Parent/carers have a right to express a preference for the school of their choice and they should do so on the application form. Expressing a preference does not, in itself, guarantee a place at this school. Application forms can be obtained from the Planning and Admissions department of the LA and should be completed by the date stipulated on the forms. The school notifies parent/carers about the school place as soon as all the applications have been considered.

4 Admission appeals

- 4.1** If we do not offer a child a place at this school, it is because to do so would prejudice the education of other children by allowing the numbers of children in the school to increase too much.
- 4.2** If parent/carers wish to appeal against a decision to refuse entry, they can do so by applying to the LA. An independent appeals panel then meets to consider all appeals by parent/carers who have been refused a place at our school and who wish to appeal against this decision. An appeals panel's decision is binding for all parties concerned. If the appeals panel decides that we should admit a child to our school, then we will accept this and continue to do all we can to provide the best education for all the children at our school.

5 The standard number

- 5.1** The standard number is the number of children the school can accommodate. The standard number for our school is 96 in each year group in years 3 – 6 and 60 in Reception, Year 1 and Year 2. We keep this number under review and the governors will apply to change the number if circumstances allow.

7 Review

- 7.1** This policy will be reviewed bi-annually with the Admissions Authority in the light of any changed circumstances in our school or the local area.

APPENDIX 1

Admissions Criteria

1. Looked After Children and previously looked after children;
2. Children with a sibling attending the school or Wickford Church of England School;
3. Children living in the priority admission area attending Wickford Church of England School and transferring into Year 3;
4. Other children attending Wickford Church of England School and transferring into Year 3;
5. Other children living in the priority admission area;
6. Remaining applications.
